

# 漢華中學 Hon Wah College 學費資助計劃

# School Fee Remission Scheme

#### 目的 Aim

本計劃旨在幫助經濟有困難的家庭繳交子女之學費,不讓學生因家境困難而失去入讀本校的機會。本校 每學年自學費收入中撥出不少於 10%作爲學費減免/獎學金之撥備。The School Fee Remission Scheme is installed to offer assistance to families with financial difficulties in paying school fees for their children, so as to avoid depriving students' opportunity to education. A minimum of 10% of the school fees received each academic year will be reserved and used for this purpose.

### 申請資格 Eligible Candidates

獲本校通知取錄之新生或舊生,家境清貧者,均可由家長提出申請。Newly enrolled students or current students come from families with financial difficulties are eligible to apply with submission made by parents.

### 申請辦法 Application Procedures

- 1. 可在學校網頁 (<u>http://www.honwah.edu.hk/hwpage1/about\_us/bursary.htm</u>) 下載或到校務處領取申 請 表 o Application forms can be downloaded from the school website (<u>http://www.honwah.edu.hk/hwpage1/about\_us/bursary\_e.htm</u>) or obtained from the General Office.
- 2. 申請人須於學年開始前提交申請。如插班生或家庭經濟突然出現困難的學生,可於學期中向學校提出申請,由學校酌情處理。一般而言,每月 23 日或之前提交之合資格申請,可望於翌月開始獲得減 觅。Applications should be submitted by the applicants before the start of the academic year. Students who are admitted to School amid the term or whose families are experiencing sudden financial difficulties may submit applications in the middle of the term for processing at school's discretion. In general, eligible applications submitted on or before the 23<sup>rd</sup> day of each month, remission may be granted from the following month.
- 3. 申請人須將塡妥之申請表連同入息或綜援/學生資助處批核結果證明文件寄回或逕交校務處。 Completed application forms with income proof or supporting documents regarding the application results of CSSA / SFO should be returned to the General Office by post or in person.
- 4. 如有接受其他計劃或基金資助,須詳述獲得資助的情況,並提交證明文件。Applicants who receive other subsidies/ grants/ allowances should provide supporting documents in their application.

# 評估準則 Assessment Criteria

- 1. 以下三類之申請將獲簡化程序優先處理: Streamlined procedures and priority will be given to the following three types of applications:
  - (1) 來自領取綜援家庭之學生,可獲全額學費減免; Applicants receiving Comprehensive Social Security Assistance (CSSA) will be granted FULL school fee remission.
  - (2) 獲學生資助處評估資助幅度爲全額者,可獲全額學費減免; Applicants receiving full financial assistance by SFO will be granted FULL school fee remission.
  - (3) 獲學生資助處評估資助幅度爲半額者,可獲半額學費減免。Applicants receiving half financial assistance by SFO will be granted HALF school fee remission.
- 2. 家庭經濟困難,如未有接受以上任何一項資助,本校將參考「學生資助處」採用之「調整後家庭收入」"Adjusted Family Income(AFI)"機制進行入息審查,以評定申請人的資助資格及幅度。算式如下: Applications of students come from families with financial difficulties or without receiving any of the above assistance will be dealt with in accordance with the "Adjusted Family Income" (AFI) mechanism adopted by SFO as the means test to assess the eligibility of a family for student financial assistance and its assistance level. The AFI mechanism is based on the following formula:

### 註:Notes

- (i) 家庭全年總收入包括申請人及其配偶的全年收入,與申請人家庭同住的未婚子女的全年收入的 30%(如適用),以及親友給予的津助(如適用)。Gross annual income of the family includes the annual income of the applicant and his/her spouse; 30% of the annual income of unmarried child /children residing with the family if applicable; and the contribution from relatives /friends if applicable.
- (ii) 家庭成員通常是指申請人、申請人的配偶、與申請人家庭同住的未婚子女,以及由申請人及/或其 配偶供養的父母。The members of a family normally refer to the applicant, his/her spouse, unmarried child /children residing with the family and the dependent parent(s) who are supported by the applicant and /or his/her spouse.
- (iii) 二至三人的單親家庭,公式中除數的 (+1) 將會增加至 (+2) ° For single-parent families of 2 to 3 members, the "plus 1 factor" in the divisor of the AFI formula will be increased to 2.
- (iv) 下表詳列 2023/24 學年的「調整後家庭收入」組別的資助幅度。請注意「調整後家庭收入」並不 是家庭每月的平均收入。The AFI eligibility benchmarks for various levels of assistance in 2023/24 school year are listed in the table below. (Please note that the AFI is not the average monthly income of a family.)

\* 2023/24 學年 3 人家庭和 4 人家庭可獲全額資助的「調整後家庭收入」上限分別為 52,657 元和 48,445 元。就 2 人和 3 人單親家庭而言,有關家庭會分別視為 3 人和 4 人家庭,以決定可獲全額 資助的「調整後家庭收入」上限及計算「調整後家庭收入」。 AFI thresholds for full level of assistance for 3-member and 4-member families are \$52,657 and \$48,445 respectively in the 2023/24school years. For 2-member single-parent families and 3-member single-parent families, they are regarded as 3-member families and 4-member families respectively for determining the AFI thresholds for full level of assistance and calculation of AFI.

3. 减免幅度:經學校審查後,決定發放全額學費減免、半額學費減免的資助,或不予資助。Amount of remission: Full, half, or nil fee remission will be decided and granted after perusal by the school authority.

### 批核及上訴 Approval and Appeal

- 1. 批核委員會負責審批所有申請。委員會成員包括校長及兩位行政主任。The Approval Committee is responsible for approving all applications. Members of the Committee comprise the Principal and two Administrative Officers.
- 2. 上訴委員會成員包括校監、副校長及一位行政主任。Members of the Appeal Committee comprise the Supervisor, Vice Principal, and one Administrative Officer.
- 3. 申請人可就學費減免申請失敗或不滿學費減免幅度提出上訴,惟上訴必須於收到批核結果後十四個 工作天内,以書面形式向上訴委員會提出申請。Applicants may file a written appeal request with the Appeal Committee against a decision of an unsuccessful application or approved amount of remission within 14 working days after receipt of the application result.
- 4. 上訴結果由上訴委員會以書面形式於收到上訴申請後十四個工作天內通知申請人。Applicants will be informed of the outcome in writing by the Appeal Committee within 14 working days after receipt of the appeal request.
- 5. 本校擁有審批最終決定權 ° It is at the final discretion of the School to grant approval for fee remission.

### 其他 Others

受助學生家庭經濟情況好轉時,應向學校報告,以調整學費資助數額。Families who receive fee remission from the School should notify the School once their financial status has improved, such that necessary adjustment will be in the amount of fee remission.

However, with reference to the Personal Data (Privacy) Ordinance, an applicant has the right to obtain access and make corrections to the information provided by him / her. The information submitted by the applicant will be destroyed upon student's withdrawal from School or after three years.
